New members will be charged 50% of their annual dues upon approval of their membership application. The remaining 50% will be charged to the card provided 30 days from the first billing.

Renewing members who submit their renewal forms before 10/31 will receive 3 guest passes to be redeemed the following golf season. 1/3<sup>rd</sup> of the annual dues will be billed on November 1<sup>st</sup>, January 1<sup>st</sup>, and March 1<sup>st</sup>.

Renewing members who fail to complete their renewal forms by 10/31 must complete a new membership application and follow the schedule of dues outlined for new members.
